2024/195 Chairman's welcome and confirmation of recording

The Chairman welcomed all to the meeting. Clerk to record for minutes only.

2024/196 Apologies for Absence were received from Cllr M Hugo at 8.30pm (family emergency)

2024/197 **Public Participation: Representations from Members of the Public** limited to 3 minutes each person: it is advised that generally no decisions will be made

(i) An email from a resident was NOTED: I just wondered whether there will be any new pathways to the new primary school site. Today I walked down the road next to the cemetery and across two fields. The main roads will be very dangerous for families and I thought that a pathway across the two fields coming out opposite the new school site would be beneficial. If you have any information on that, I look forward to hearing from you.

Cllr G Kelly commented that the plan is to provide a footpath at Maids Cross Way, down Marabella footpath and through to Barr Drive. There is a stumbling block in that the school has been put back because of transport and lighting issues (draft minute copied to resident 10/04/2024)

2024/198 Reports & Questions

- a. <u>An update from West Suffolk District Councillor D/Cllr G Kelly</u> had been sent to all councillors prior to the meeting and hard copy provided at the meeting. *(Appendix A)*
- b. <u>Update from Suffolk County Councillor C Noble</u>: you will all have seen that your council tax bill has gone up. The increase in national minimum wage has impacted and it in the pothole season. I disagree with the way in which we deal with them.

Lots of money is spent on adult and children's social care, the vast majority is not visible expenditure.

The school will still be built before the houses.

On the Persimmon site, there will be some houses for social rent i.e. not Americans I have been going around with our new candidate, talking to people.

Q Completion date for school?

A: No, depends on housing, certain trigger points will have to be hit

Councillors expressed thanks for the re-painted zebra crossing and for filling in the pot hole outside the Wok and Roc

Reminder: Men's Shed breakfast this Saturday

C/Cllr C Noble left the meeting

c. <u>D/Cllr R Dicker, Chair of West Suffolk Council</u> (Independent) Kentford & Moulton ward including Gazeley, Higham, Kentford and Moulton

I have been a councillor for 19 years, including the old Forest Heath area, particularly Newmarket, Gazeley and Higham.

The Independents took control at the last election. I am going round to as many meetings as possible. The District Council meetings have experienced a u tube sensation, an invasion, the police had to be called, leeway had been given but was this was sadly abused

I enjoy being a councillor and I run post office, like meeting people, tend to get outside of the district, spreading goodwill around

I knew David Gathercole very well

Q: How do you recruit post office workers nowadays?

A: Post office pay is very poor, it's sad. Lots of stuff is bought online.

Q: You mentioned an increase in councillors?

A: Yes, because of the `merger` of Forest Heath with St Edmundsbury.

D/Cllr Dicker remained for the duration of the meeting

2024/199 <u>Confirmation of accuracy of the Minutes of the LPC Meeting held on 4th</u> <u>March 2024</u>

The minutes were unanimously **AGREED** as an accurate record and the Chairman authorised to sign the same.

2024/200 Payment of Accounts (Appendix B)

- a. The Bank reconciliation for month end 29th February 2024 was unanimously AGREED
- b. The Summary of payments for authorisation were considered and unanimously AGREED

2024/201 Parish Report- Chairman/ Clerk on recent and forthcoming issues/

topics

- a. <u>Update on Lakenheath Post Office</u>: there are two potential post office managers looking at it, one of whom is the purchasers of the old post office. Post office Ltd have been down and have been talking to people. The economic development team at West Suffolk have been understanding and will assist whoever the next manager is.
- b. <u>Update on new School</u>: Information is that it will not be an academy, it has already been agreed that it will be a council run school. Sept 2026 is the revised start date, a tight timescale.
- c. <u>Update on old school building</u>: LPC refuse to allow this to atrophy, as in so many other cases, we are not going to let boredom set in and see the land being sold for housing development.
- d. Update on 17 Cemetery Road refurbishment

Cllr Gyte reported that the refurbishment is just about complete. The carpets are scheduled to be fitted next week

Councillors to decide whether to rent or to sell.

Cllr Gyte has spoken with a person who was an agent about the local market

In order to progress this with the least delay, a Working Party was set up work on LPCs next steps

It was **RESOLVED** to allow the Working Party delegated authority to progress this initiative. It was **AGREED** that the Working Party would comprise:

Cllr M Rowntree; Cllr J Hastings; Cllr W. Overy; Cllr A. Gyte and Cllr N. Smith.

The first step will be to arrange for all councillors to visit should they wish to do so.

Secondly, a written estimate of a realistic rent to be obtained from two

reputable local Agents.

The allocation of the property will be non-discriminatory and fair.

The Working Party to suggest to the Council how the property should be managed

Cllr A Gyte proposed a Motion that:

The property at 17, Cemetery Road is rented out and not sold. The proposal was seconded The vote was: **8 FOR, 2 ABSTENTIONS.** Motion **CARRIED**.

Cllr W. Overy left the meeting (prior engagement)

 <u>West Suffolk Council Parish and Town Forum 18th March 2024</u> (the relevant report and slides had been previously circulated to all Councillors) This had included advice on LPC Emergency Planning, Cllr J Hastings is working on the LPC Emergency Plan and will incorporate the new ideas. The Highways item was most interesting.

f. Cllr M Rowntree had commented in a recent email how lovely the bulbs we planted look. The Chairman commented that the patch at Village sign and Hall Drive has made a remarkable change.

There have been comments about some trees that have been planted close to the wall (near the village sign), Cllr J Cahill will investigate.

Once the bulbs die off, the poppies will come through and then the areas will be left as wild sites.

2024/202 Lakenheath Parish Councillor/ Officer Reports

- a. <u>Business forum</u> Cllr W Overy is in touch with businesses regarding Lakenheath Times
- b. <u>Environmental update</u> Cllr J Cahill confirmed that once the poppies have died back then the wild flower meadow flowers should come through. She will have a look at the trees but suspects that they are all dead. There was a litter pick on Saturday, four members of the public took part. Cllr Cahill worked on the car park, which she believes still needs more work. The RFO to confirm the environmental budget that had been discussed and agreed previously.

Cars are driving on Mutford Green off onto the main road. One idea is to block this with matching planters. The Chairman confirmed that he had spoken with West Suffolk and length and in detail about this, and the authority have agreed to tell all the owners that they are parking on private property, if this persists the cars will be clamped and hefty fine will be payable. Cllr Kelly will chase.

c. <u>Lakenheath Streetlights</u> Cllr I Frost reported that

the streetlight survey had confirmed that LPC have 75 non-LED streetlights. Additional costs will be covered bu the grant. Still awaiting figures from UK Power Networks.

It was **unanimously AGREED** to

- (i) Accept the quotations from Pearce and Kemp
- (ii) Accept the grant offer of £71,502.69

The clerk congratulated West Suffolk Council for the provision of this much needed boost to rural council finances, which will allow our streetlights to operate in a cheaper, more environmentally friendly manner.

d. Speed Indicator Device Report (Clerk)

The clerk reported on the forcible removal of the old Speed Indicator Device and asked the Councillors to consider the purchase of a second solar SID device *(Appendix C)* It was **unanimously RESOLVED** to purchase a second solar/ battery powered Speed Indicator Device at a cost of £4,636.00 (excluding VAT) from Westcotec in Dereham, Norfolk.

The SID Report for March 2024 was **RECEIVED** (Appendix D)

e. <u>Speedwatch team</u> (Cllr P Gyte) Police Officer Andy Green and PCSO Hannah Rogers have visited the group. A site near the Persimmon development was rejected because it was too near the 30mph sign and was only a temporary site while the development is in progress.

- f. <u>Neighbourhood Plan / High Street regeneration</u> (Cllr Kelly) Ian Poole, our consultant has not been well, C. Shimmon is chasing him.
- g. <u>Planning Sub Committee</u>: The Notes from meeting held on 20th March 2024 were **RECEIVED** (Appendix E)

Comments about scheduled meeting on 10th April:

- The Murfitts industry application has been the source of many complaints from Hockwold residents, both noise and light pollution.
- At Rookery Farm, permission is sought for eight houses. The issue is that trees have already been taken down. This will create yet more traffic.
- Another Highbridge application: there appears to be no reference to the previous application (or any acknowledgement that it has been refused). The only change appears to be a collection of supportive letters from people who do not live in Lakenheath.
- h. <u>Lakenheath Times</u> Cllr D Smith: All advertisers have been contacted, articles and advertisements are coming in.

Layout will be worked on by email. Cllr Hastings suggested a featured charity, and that the Parish Council donate £100 to each highlighted group.

The Chairman thanked Cllr Rowntree for his editing assistance on LPC Facebook page.

 <u>Review of the 2023 Christmas decorations</u>: Cllr P Gyte has been in touch the Brandon clerk, Donna Allen, as the icicle lights that Brandon put up are effective. The display s organised by Alison who will come over and walk High Street with Cllr P Gyte.

Giant flags will hang from the flagpoles, and the lamppost soldiers will return.

j. <u>Lakenheath defibrillators</u>: situation and condition: The Chairman has heard no more. The situation is urgent. It was unanimously **RESOLVED** that LPC take over ownership of all the defibrillators.

Councillors noted that the defibrillator formerly at Quayside has been relocated. The Chairman will ask Mrs W Barnes and her group to keep LPC informed as to the condition, electrical supply and siting of all defibrillators.

- k. LPC publicity had been discussed. All grant beneficiaries should attend the Annual Assembly.
- I. A copy of the definitive Rights of Way for Lakenheath was **RECEIVED**.

2024/204 Matters relating to the Play area

- a. <u>The Playground condition report</u> from the West Suffolk Council inspector was **RECEIVED**. Councillors considered the report and noted that all reported fails are low risk and will be dealt with in turn.
- b. <u>Installation of the replacement accessible roundabout</u>: authority had been delegated to Cllr Rountree and the clerk. It has been **RESOLVED** to accept the quotation from 1A Play at 10,927.14 (excluding VAT) (*Appendix F*)

2024/205 Matters relating to Lakenheath Cemetery

a. The Cemetery Committee reported that the Cemetery is neat and tidy, unfortunately the Chafer grubs are back. Clerk had sought advice and May is the earliest month that nematodes are deemed to be viable as a treatment. A second solution that has been put forward is to dig out the Chafer bugs then overseed. Nemotodes will need to be well watered.

2024/206 Matters relating to Street Furniture

a. <u>Red Telephone boxes</u>: update from Cllr Hastings on a plan which will allow all village groups to display their activities on a rota basis: Cllr Hastings is obtaining painting quotes and for plastic boards. Cllr Rowntree suggested that the box may be better left as a library. LPC to involve the parishioners, and ask residents what they would prefer to be done with the phone box.

2024/207 Grant Requests

Tommy's sleep out raised over £1k in cash. It was unanimously **RESOLVED** to donate £100. **NOTED** that this is for 2024 and not an annual donation, no precedent is implied.

2024/208 Matters relating to Governance

- a. Review of the LPC Asset Register: clerk to consult with Cllrs N Smith, A Gyte and the RFO to finalise.
- b. The LPC Financial Regulations from the RFO were reviewed and unanimously AGREED.
- c. The LPC Cemetery Regulations to be reviewed in August: change to headstone height measurement, and other descriptions which have altered.

2024/209 Items for Future Meetings

- Clerk has heard from Lucy Sagrott, the Active Communities Lead She awaits replies as to venue from the Pavilion and Community Centre (front bit of grass). The consensus of the survey was sessions on a Saturday or Sunday morning or on a Thursday evening, it looks like the most popular activity was yoga/Pilates.
- 2. Plans for the Youth Club are going well, Linda Spencer will keep LPC updated.

Appendix A Update from D/Cllr G. Kelly Council meetings

March was quiet so far as formal decisions were concerned. Interestingly (to me anyway) one thing agreed at the Council meeting was a change to the Constitution. The Scrutiny Committee is losing two Members to make room for two external "lay" people. This is a move which puts some external oversight into the Council's working.

Pay was also discussed. What might seem a very dry subject - because pay for nearly all Council staff is set by national agreement – did highlight that the Gender Pay Gap at West Suffolk is actually negative, so women earn more than the men. One of those whose pay is set locally is the Chief Exec, who guidance says should not get more than 12 times the lowest paid; actually, he is getting half that!

Town & Parish Forum

We had the first locally run Town & Parish Forum held in Mildenhall. Apart from most people assuming it would be in the Hub and really rubbish acoustics it went reasonably well with most interest being unsurprisingly aimed at SCC Highways. What isn't in the paperwork which you have received were a couple of issues which Highways have agreed to pick up. First was around flooding and the part played by blocked drains, exacerbating and exacerbated by potholes, and the other was around reporting. There were a lot of complaints about cases being closed almost as soon as they are reported but nothing is done. The response was that this only happens if Highways are aware of a problem and has been put into a programme for repair. Of course, if nothing has happened a fresh report may be duplication, but it may equally be because the problem has worsened, and several examples of this from around the District were quoted.

A reminder from this meeting is that we do need to revisit our Emergency Plans, looking particularly at the requirements of TAP3 around Climate Change, so issues around flooding and heatwave.

Abbeycroft Leisure

At the last Parish Council meeting we heard from Abbeycroft about the opportunity for some funded activity in Lakenheath and the sorts of activity available in Mildenhall and Brandon. We also heard of the plans to establish a Youth Club in the village. I am really pleased to report that Abbeycroft have since been advising our local volunteers so that is really promising.

Joining in

Possibly the most disappointing thing about District, and even county wide things that I am involved with, is the number of times there are grants handed out or awards given and there's nothing for north of the A14. In nearly a year the only time anyone appears to be doing or to have done anything was when I was delighted to attend an award from Active Suffolk to our Primary School; we all know it's not because we don't do anything – we just don't apply! Literally millions of pounds are distributed to projects and organisations each year but if you don't ask you won't get. I'll be making sure the new Youth Club will be bidding, but if you know of projects that need help or deserve some public acknowledgement, do please let me know.

Appendix D SID Report

On 15 June 2023 at 10:00 the new SID was installed on the B1112 on the pole located on Station Road. The SID was positioned to monitor traffic coming into Lakenheath from Wangford. Traffic speed and counts were measured from 00:00 on 26 February 2024 up until 13:59 on 20 March 2024.


The measurement point is 450m past the point where the 30MPH zone starts. There are between 3000 and 3500 vehicles per weekday passing this point heading into Lakenheath. There are

between 2100 and 2200 vehicles per day over the weekend heading into Lakenheath. The busiest times during the week are 07:30-08:30 (Avg. 260 cars p/h) and 16:00 -17:15 (Avg. 340 cars p/h).

The 85th Percentile Speed (most people) travel at or below 34.6 MPH past his point. The 50th Percentile Speed (half the traffic) travel at or below 28.9 MPH past his point.

The fastest speed recorded this month was 85MPH (x2). There were also 281 vehicles exceeding 50MPH. The next pages show: Speed vs vehicle counts at the point listed above - Average hourly volumes passing this point - Typical daily volumes passing this point. - Speed exceedances of 35MPH for this period


The Battery measured 12.4V on 20/03/2024. PV panel should be rotated towards trees (facing south) to gain maximum exposure to available winter sun. For the most effective use of the Solar PV panel, and safe access for operations personnel, a pole should be erected at https://what3words.com/shun.petty.plank and the SID and PV moved to this location.
