2025/93 Chairmans welcome, confirmation of recording and Apologies

Clerk to record for minutes only. Apologies had been received from A Blenkiron, W Barnes, Cllr I Frost.

2025/95 Reports & Questions

- (a) Update from RAF representative: complaint that this is about the 3rd absence. LPC had been assured by Cmdr. Eaton that either a representative will be sent or a report sent in. Clerk to query.
Report from Eriswell PC which had been given by John Tillottson and thought to be still relevant:
- (i) US Govt failure to produce a budget: no-one working on base will be affected, but there will be issues, US personnel may not attend Remembrance Day Services.
 - (ii) There were 881 sorties in October, between October 2024 and September 2025, there were 10, 214 sorties. Cllr Kelly noted that the MoD criteria for planning is based on `occasional` sorties. 10.3 million gallons of aviation gas used.
Note: there had been a report from the liaison officer, V. Quamina, sent late in the afternoon of the day of the meeting which has subsequently been shared with all the councillors (**Appendix A**)
- (b) Update from West Suffolk District Councillor Cllr G Kelly: Arrangements for EV chargers that were due to happen soon, Suffolk County Council have changed their contractor, process now delayed.

Pride in Place initiative: still no guidance from government as to procedures.

West Suffolk will get a `letter of comfort` to enable the advancement of up to £2million.

Representatives from Eriswell and Lakenheath PCs met with the West Suffolk Council Leader, Cliff Waterman, to consider local government reorganisation.

Map includes Lords Walk some issues affect the whole area e.g. bus services.

Around 800 houses have been built so far, almost 800 to come.

Anglian Water are sending leaflets about flooding – holding objection for Station Road site.

- (c) Update from Suffolk County Council Councillor: not present
- (d) Update from Police representative: PC Cameron is on holiday, has sent update
See **Appendix B: Chairman to contact PC Cameron about an incident at Sedge Fen.**
- (e) Update on Active Lakenheath project Lakenheath Community Connector, Richard Keeble, thanked the councillors for their support. It has been a full month, the 26th October 2025 carpet bowls and mini golf event was very positive, with 22 attendees. Several people decided to continue with carpet bowls. A similar session is scheduled for Sat 30th November 2025.

Held on 1st November, the pony rides experience included chili, hot dogs- an opportunity for forty local children to try horse riding, we are hoping to hold another session.

Cooking sessions have had to be postponed till January 2026. This was restricted to foodbank users; the January event will be more inclusive. Cllr Rowntree commented that the cooking sessions could be held at a better time of day, when children were at school.

A menopause group is being arranged at Lakenheath Library.

A mini golf session will be offered at the Men's Breakfast.

An Afternoon tea and Mini golf activity for ladies is planned for Saturday 14th March 2026.

170 online surveys have been completed, still distributing postcards.

The Community Connectors will be outside the Co-op with a stall this Wednesday 9am to 12noon. On 12th November, there will be a stall at Lakenheath Surgery.

There will be an Open Evening event on Tuesday 18th November at Lakenheath Pavilion, 6pm to 8pm.

Cut off date is 2nd December, after which the bid will be submitted.

The project website is active.lakenheath.org

Richard asked if a dedicated Facebook page would be considered.

Cllr N Smith commented that Active Lakenheath news etc. is already being posted on the LPC Facebook page.

(d) Report from Wendy Barnes on Sedge Fen Village Hall opening apologies had been given by Mrs Barnes. Clerk to ask for a report on progress of the refurbishment. Cllr Alan Gyte has resigned from the Sedge Fen Village Hall Management Committee.

Cllr D Smith has not had a response to her request for an article for Lakenheath Times.

- (i) Update on 2025 Abbeycroft Move More Awards 17th October 2025 Cllr Kelly, Vice Chairman, attended the event. Lakenheath had a winner in the 'Unsung Hero' category Richard Horrex of Football club. Councillors felt that this was well deserved well-deserved and congratulated Mr Horrex.

LPC were joint second in the 'Most Active Village' category.

- (ii) Update on meeting held on 27th October 2025 with neighbouring parish councils and West Suffolk Council Leader Cliff Waterman: Councillors attending agreed that this was informative, helpful, positive.

- (iii) Speed Indicator Device September Reports (**Appendix E**)

Eriswell Road unit: There were between 4100 and 4500 vehicles per weekday passing this point heading into Lakenheath.

There were between 2500 and 3400 vehicles per day over the weekend heading into Lakenheath.

The 85th Percentile Speed (most people) travel at or below 31.1 MPH past his point.

The 50th Percentile Speed (half the traffic) travel at or below 27.1 MPH past his point. The fastest speed recorded this month was 65MPH (x4).

149 cars exceeded 45 MPH.

19% of the vehicles passing this point exceed the speed limit.

Station Road unit:

There were between 3400 and 3800 vehicles per weekday passing this point heading into Lakenheath.

There were between 2100 and 2800 vehicles per day over the weekend heading into Lakenheath.

The 85th Percentile Speed (most people) travel at or below 34.4 MPH past his point.

The 50th Percentile Speed (half the traffic) travel at or below 28.6 MPH past his point.

The fastest speeds recorded this month was 100MPH (x3), 95(x1), 90MPH (x5), 85MPH (x5). There were 402 vehicles exceeding 50MPH.

38% of the vehicles passing this point exceed the speed limit.

The plan is to have toucan crossing this side of Barr Drive and also at Liberty Gate, From the SID results, it is evident that traffic lights successfully slow traffic. Cllr Kelly is pressing for these crossings both informally and formally.

- (iv) Cllr N Smith told the meeting that the Remembrance Day event on 9th November 2025 is organised. The Rector will arrive at 2pm. There are 28 wreaths to be laid. The Community Centre are providing tea and coffee.

Katrina is coming from America to play the Last Post; the Silver Band will be in position; the Order of Service has been printed.

This has been shared widely internally in many forms, across spouses and family groups as well as service members to include RAF Mildenhall.

- RAF Lakenheath support nearly 30 Remembrance events with many airmen attending services throughout the region.
- The annual Thanksgiving event at Ely Cathedral will be held on Weds 26 November; Council Chairs have been invited with their families to join the tri-wing service.
- The annual Yuletide Reception is at RAF Lakenheath this year on Thursday 4 December; Council Chairs have been invited with spouses to this event.
- As you may be aware, the US government has shutdown until a new spending bill can be passed. Until then, servicemembers may have difficulties with their pay and support services. This has already led to the cancellation of US personnel's support to local civic engagement events from all the US Visiting Forces within the UK, and RAF Lakenheath is no exception.

Whilst we are still awaiting a firm decision on support to Remembrance events, it would be sensible to start planning for the possibility that US personnel will not be able to attend any Remembrance events in uniform, provide any marching contingents, lay any wreaths, or deliver any readings this year. This is not a decision that is being made within the UK, but there are strict limitations on any kind of fiscal commitment at civic engagements that they have to adhere to if the shutdown continues.

Appendix B

Report from PC Scott Cameron: Thanks for the invite, unfortunately I will not be attending the meeting. This date is on one of my rest days.

Please send my apologies for my non-attendance and could you update with the following: I had sent an email off to our safety camera team in Suffolk regarding speeding concerns in your village and the surrounding area. I also attached all the speeding stats on the spreadsheet you sent over. They replied and have agreed to install a Speed Detection Radar (SDR), this will show the extent of the speeding issues and ascertain what actions we can take moving forward.

We conducted a traffic operation at RAF Mildenhall on the 9/10/25. This was a successful day. We had in attendance, traffic units, Military Defence Police, Security Forces and community police. The operation ran from 9.30am to 1.30pm, a total of 88 vehicles were stopped, 33 offences were identified (37.5%). A similar operation will be conducted in and around RAF Lakenheath soon. I will update these results in next months meeting.

I conducted a community engagement outside the Co-Op recently. I was accompanied by a local PCSO from Brandon. During our engagement I attended many of the High Street shops and spoke to multiple members of the community. I also dealt with some of the individuals who were parking outside the Co-Op on the crossing.

I have spoken to a community police officer from Mildenhall who is keen to set up and conduct another operation for illegal riding of motorcycle on our roads and green areas. No

dates have been discussed yet, but it will take time to organise as this will require several officers to ensure we can not only identify them but stop them for evading us.

My input for the Lakenheath times has been sent off and hopeful that it will appear in the next edition.

No other updates.

I can see that your next meeting is potentially the 1/12/25, which I should be available for.

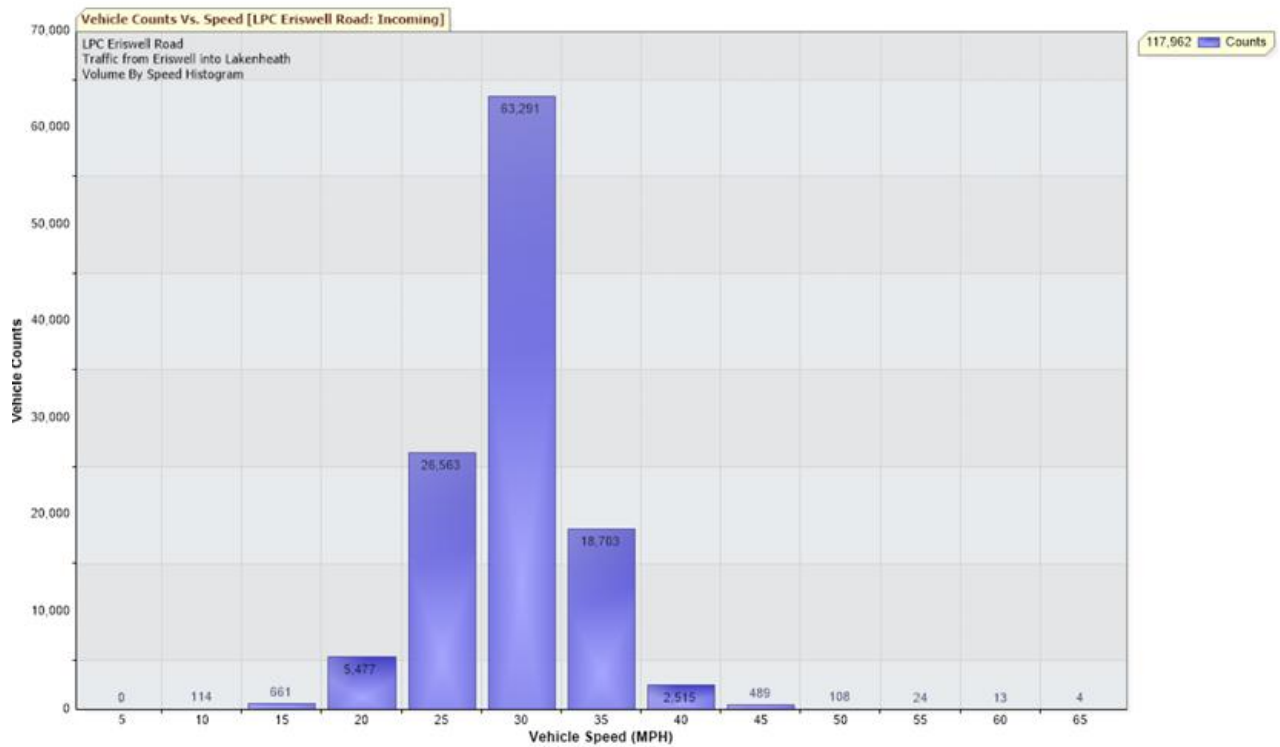
Traffic speed and counts in this report were measured from 00:00 on 31 August 2025 up until 23:59 on 30 September 2025. The measurement point is 740m past the point where the 30MPH zone starts.

There were between 4100 and 4500 vehicles per weekday passing this point heading into Lakenheath.

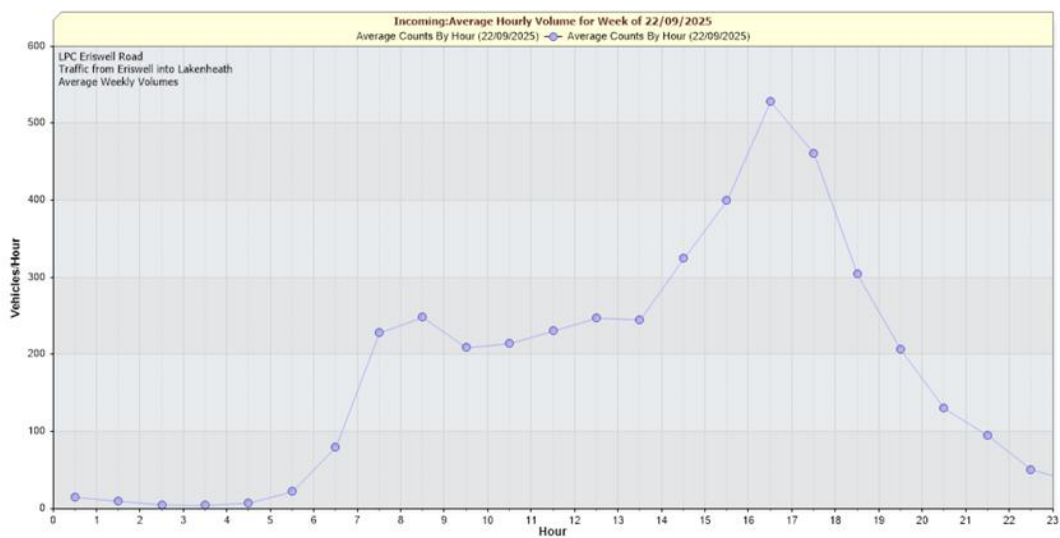
There were between 2500 and 3400 vehicles per day over the weekend heading into Lakenheath. The busiest times during the week (AM and PM peaks) are 07:45 -08:45 (Avg. 265 cars p/h) and 16:00 17:00 (Avg. 508 cars p/h). The 85th Percentile Speed (most people) travel at or below 31.1 MPH past his point. The 50th Percentile Speed (half the traffic) travel at or below 27.1 MPH past his point.

The fastest speed recorded this month was 65MPH (x4). There were 149 cars exceeding 45 MPH. 19% of the vehicles passing this point exceed the speed limit.

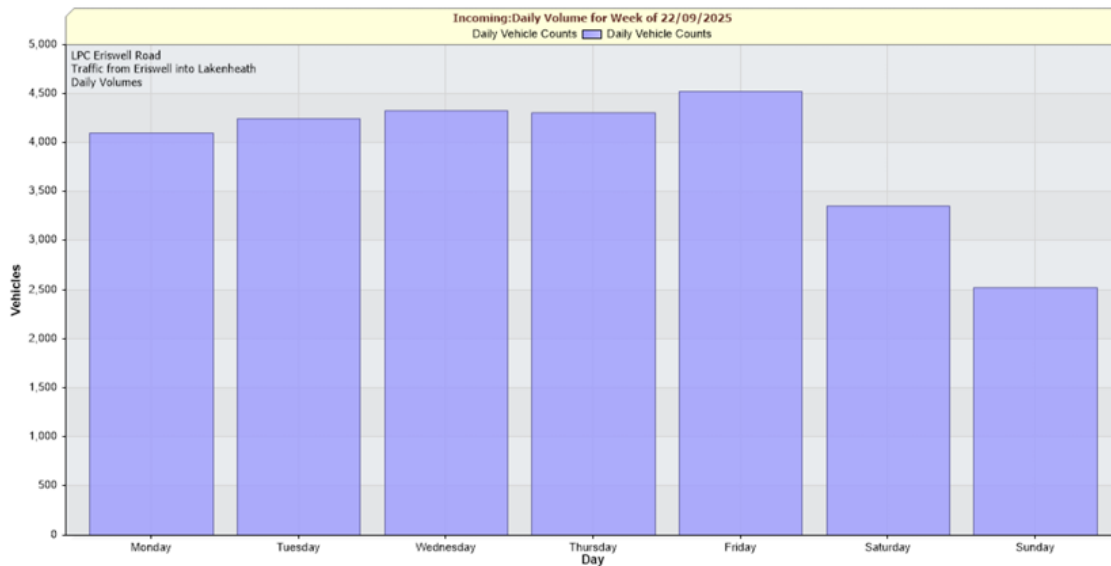

Exceeding Speed of 35MPH – September 2025

Lakenheath Parish Council Traffic Report Station Road September 2025

On 15 June 2023 at 10:00 the new SID was installed on the B1112 on the pole located on Station Road. The SID was positioned to monitor traffic coming into Lakenheath from Wangford. Traffic speed and counts in this report were measured from 00:00 on 31 August 2025 up until 23:59 on 30 September 2025. The measurement point is 700m past the point where the 30MPH zone starts. 3.5 days of data recording was lost due to the battery going flat. There were between 3400 and 3800 vehicles per weekday passing this point heading into Lakenheath.

There were between 2100 and 2800 vehicles per day over the weekend heading into Lakenheath.

The busiest times during the week are 07:45 -08:45 (Avg. 271 cars p/h) and 15:45 - 16:45 (Avg. 305 cars p/h).

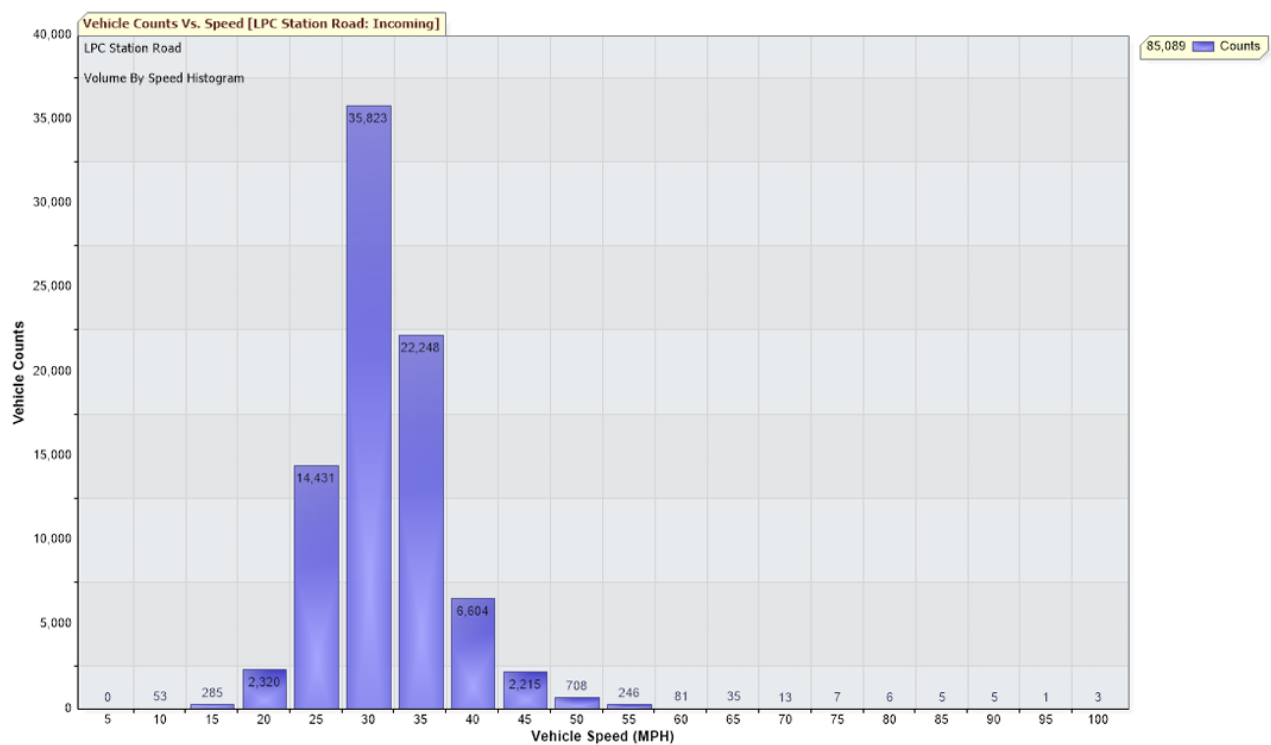
The 85th Percentile Speed (most people) travel at or below 34.4 MPH past his point.

The 50th Percentile Speed (half the traffic) travel at or below 28.6 MPH past his point.

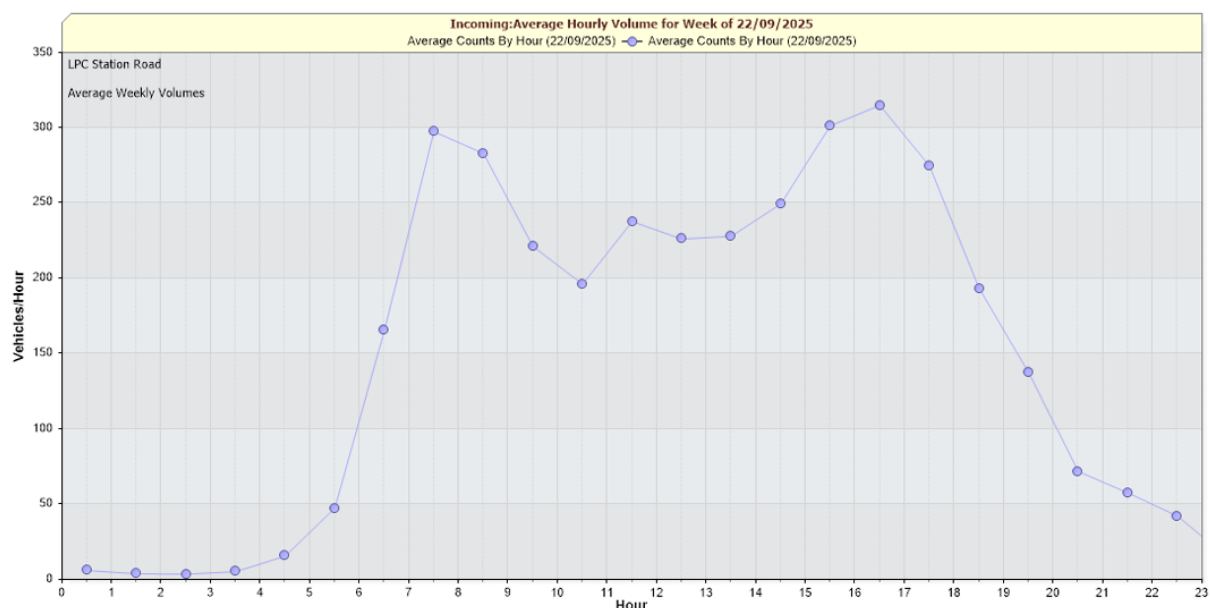
The fastest speeds recorded this month was 100MPH (x3), 95(x1), 90MPH (x5), 85MPH (x5).

38% of the vehicles passing this point exceed the speed limit.
